Important changes relating to Fidelity's range of UK-domiciled open-ended funds

25 March 2020

Dear Shareholder,

The Board of Directors of FIL Investment Services (UK) Limited, the management company of Fidelity's UK-domiciled open-ended funds, has decided to temporarily revise the current normal market Swing Pricing policy of these funds.

We feel this action is in the best interest of investors. It has been taken as a result of the recent increase in financial market volatility and the subsequent negative impact on liquidity conditions across all asset classes.

Due to the current market environment and the liquidity conditions experienced throughout March 2020, we believe that the current maximum expected adjustment for normal market conditions of up to 2% does not adequately reflect the disconnect between prices used in the Net Asset Value calculation of each fund and trade execution prices.

In order to protect the interests of Shareholders and to ensure that trading activity is implemented at a fair price, the Board has decided to lift the current expected 2% ceiling on a temporary basis until further notice.

Please note that you do not need to take any action as a result of this change and it will automatically become effective on 25 March 2020. A full list of individual funds impacted by this change can be found in the appendix of this note.
